GIVEN the resolution of the Board of Governors of 28 November 2002 which established that applicants should make a payment to partially cover secretarial expenses and which determined the amounts;

GIVEN the Guidelines for the "Conduct of recruitment procedures for full and associate professors and fixed-term researchers via videoconference", adopted by Rector's Decree no. 344 of 11 April 2022;

SEEN Law No. 199 of December 30, 2025 (2026 Budget Law) and, specifically, Article 1, paragraphs 305-309, which authorizes state universities to hire fixed-term Tenure Track researchers, subject to the completion of procedures reserved for contract holders pursuant to Article 24, paragraph 3, letter a) of Law No. 240/2010 (RTDa) expiring in 2025 and 2026;

SEEN Ministerial Decree No. 193 of March 5, 2026, relating to the "Extraordinary Plan for the Recruitment of Fixed-Term Researchers 2026-2027," which defines the distribution of resources allocated by the 2026 Budget Law for co-financing recruitment procedures for Tenure Track researchers, pursuant to Article 24, paragraph 3, Law No. 240/2010 (RTT), reserved for RTDAs, i.e. researchers pursuant to Article 24, paragraph 3 of the same law, in the provisions prior to Legislative Decree No. 36 of April 30, 2022, converted with amendments by Law No. 79 of June 29, 2022, with contracts expiring in the two-year period 2025-2026;

SEEN the Ministry of University and Research Circular No. 313 of April 14, 2026, containing clarifications regarding the aforementioned extraordinary plan;

WHEREAS, pursuant to the aforementioned Ministerial Decree No. 193/2026, the procedures in question must be completed by December 31, 2026, with successful candidates taking up employment no later than March 31, 2027;

SEEN the resolution of the Board of Directors of 12/17/2025, relating to the adoption of the Three-Year Personnel Plan 2026/2028, as updated on 03/27/2026 in order to incorporate the quota referred to in the aforementioned Extraordinary Plan

GIVEN the resolution of the Board of the Department of Department of Humanities and Cultural Heritage dated 08.04.2026 which requested the initiation of a selection procedure for the recruitment of a fixed-term researcher in tenure track, pursuant to Article 24 of Italian Law no. 240 of 30 December 2010, as amended by Italian Law no. 79/2022, with full-time commitment, for the 10/ITAL-01 Italian Literature subject area group and ITAL-01/A Italian literature subject area;

GIVEN the resolution of the Board of Governors of 24.04.2026, which, after acquiring the favourable opinion of the Academic Senate expressed by resolution of 21.04.2026 approved the departmental proposal for the call of ONE (1) fixed-term researcher in tenure track (RTT) pursuant to Article 24 of Italian Law no. 240/2010, for the scientific and teaching needs of the Department;

ACKNOWLEDGING that the position in question has the necessary financial coverage in line with University planning;

HAVING ASCERTAINED that it was appropriate to implement the resolutions taken by the Academic Bodies for the recruitment of 1 fixed-term researcher in Tenure Track (RTT) pursuant to Article 24 of Italian Law no. 240/2010, taking into account the scientific and teaching needs of the Department of Humanities and Cultural Heritage;



**DECREES**

**Article 1**

Notice of the procedure

A comparative evaluation procedure, based on qualifications and public discussion, is announced for the recruitment of one fixed-term Tenure Track Researcher, pursuant to art. 24 of Law 30.12.2010 n. 240 (as amended by Law n. 79/2022), reserved for contract holders pursuant to art. 24, paragraph 3, letter a) of Law 240/2010 (previous text) expiring in 2025 recruited as part of projects funded by the PNRR, with the following characteristics:

**Competition code:** 2026RTT34\_10ITAL01\_DIUM

**Department:** Department of Humanities and Cultural Heritage

**Subject Area Group:** 10/ITAL-01 Italian literature

**Profile by indication of the subject area:** ITAL-01/A Italian literature

**Duration of the contract:** six years

**Form of Commitment:** full-time, with a total annual commitment for teaching activities, supplementary teaching and student tutoring of 350 hours

**Research project: Towards a Historical and Critical Reappraisal of the Scapigliatura: Political Ideologies, Poetic Language, and Style.**

Description: This project seeks to contribute to a renewed historical and critical understanding of the Scapigliatura by means of a linguistic, stylistic, and metrical analysis of its poetic output. More specifically, following a focused reconstruction of the movement's ideological contexts during the Risorgimento, the study will investigate the pursuit of a new norm for Italian poetic language, together with a reassessment of its traditional forms and conventions, in response to the compelling expressive demands of poetic modernity across the long nineteenth century

**Professor in charge:** Prof.ssa Silvia Contarini, professor at the University of Udine

**Facility where the activity is performed:** Department of Humanities and Cultural Heritage

**Specific functions and assigned objectives:** The following scientific productivity goals are required of the researcher: 1. The publication of monograph of high scientific quality; 2. At least articles in top-tier Italian or international scientific journals; 3. Participation with a presentation at national or international conferences of recognized scientific quality and/or the organization of conferences and seminars related to the research topic.

**Teaching activities, supplementary teaching and student tutoring:** Teaching and supplementary teaching activity (70 hours/year): The researcher will be assigned the following courses: Digital Italian Studies (Master's Program in Italian Studies, 30 hours, 6 credits); Contemporary Publishing (Bachelor's Program in Humanities, Publishing track, 40 hours, 6 credits). In addition to teaching activities and the related examinations, the researcher will be required to assist students by serving as supervisor or co-supervisor of undergraduate and master's theses.

**Maximum number of publications to be submitted:** 12

**All documents relevant to the procedure will be published on the University's Official online Notice Board and this will in all respects be considered as legal notification thereof.**



## **Article 2 Eligibility requirements**

Italian and foreign candidates holding a PhD or equivalent qualification, obtained in Italy or abroad, and holding a fixed-term Type A research contract (RTDa – pursuant to Article 24, paragraph 3, letter a) of Law No. 240/2010, in the version in force prior to the entry into force of Law No. 79/2022) expiring in 2025, recruited as part of projects funded by the PNRR, are eligible to participate in the selection process.

As clarified by MUR Circular No. 313 of April 14, 2026 cited in the preamble, both three-year Type A fixed-term researcher contracts started in 2022 (natural expiration of the three-year period in 2025) and contracts that have obtained two-year extensions that began in 2023 (expiration of the two-year period in 2025) are considered "expiring" in 2025. Any early terminations of contracts with a later expiration are not relevant. In other words, if a Type A fixed-term researcher has already obtained an extension of the natural three-year period that was expiring in 2025 (contract started in 2022), the extension does not prevent access to the selection process.

Only RTDAs fully funded with resources relating to the following are considered recruited with PNRR funds:

### **The eligibility requirements must be met by the deadline for timely submission of applications for admission to this selection.**

In the case of a PhD obtained abroad, it is necessary either to be in possession of:

- a decree of academic recognition of the foreign degree (**so-called "equipollency"**), issued by an Italian University pursuant to Article 74 of Italian Presidential Decree no. 382/1980.

If candidates are already in possession of the decree of academic recognition of the foreign degree, they must attach it to their application for participation in the selection.

Candidates who are not in possession of the aforementioned decree, must submit a request for recognition of the degree to an Italian University, pursuant to Article 38(3.2) of Italian Legislative Decree no. 165/2001, and attach the receipt certifying receipt of the request, to their application for participation, under penalty of exclusion from the selection procedure.

The University of Udine issues the decree of equipollency of the foreign PhD degree if comparable to PhD degrees active at the University itself. For more information on the procedure, applicants can consult the University's website:

For PhDs not active at the University of Udine, applicants must apply to another University.

**or**

- a provision of non-academic recognition of the foreign qualification (**so-called "equivalence"**) for the purposes of participating in competitions for posts as researcher in universities and public research bodies, pursuant to and for the purposes of Italian Legislative Decree 206/2007, amended by Italian Legislative Decree 15/2016 (for EU qualifications) and Italian Presidential Decree 394/99, Article 49 (for non-EU qualifications).

Applications requesting a declaration of recognition of the foreign qualification for access to public competitions, with reference to the procedure the person concerned intends to participate in, must be submitted to the Presidency of the Italian Council of Ministers (Civil Service Department – P.P.A. Office – Recruitment Service) and, at the same time to the Italian Ministry of Universities and Research (MUR), following the instructions indicated on the web page:

Pursuant to Article 38(3) of Italian Legislative Decree 165/2001, it should be noted that the Civil Service Department only concludes the recognition procedure for successful candidates in competitions, who have the obligation, under penalty of forfeiture, to submit an application for recognition within fifteen days of the publication of the final ranking list.

Candidates must send the receipt of delivery of their request together with their application for participation, under penalty of exclusion from the selection procedure.

Applicants who, on the expiry date of the call for applications, are not in possession of the above documents are allowed provisionally to participate in the competition, pending the issuance of the provision referred to in the previous points.

The documentation proving the recognition of equipollency or equivalence of the foreign qualification with the Italian one must in any case be produced to the Administration at the time of signing the contract, under penalty of forfeiture of the right to be hired.

The aforementioned requirements, where necessary, will be checked by the Selection Board.

**Prospective candidates will be deemed ineligible** to participate in the selection procedure, if, at the expiry date of the call for applications, they:

- are excluded from the enjoyment of civil and political rights;
- have been dismissed or dispensed from employment with a Public Administration due to persistent insufficient performance;
- have been declared to have lost their right to another position in state employment, pursuant to Article 127(d) of Italian Presidential Decree no. 3 of 10 January 1957;
- have incurred criminal convictions incompatible with the status of public employee that would entail, on the part of the University that issued the call for applications, the application of the loss of right to employment pursuant to Article 127(1)(d) of Italian Presidential Decree no. 3 of 10 January 1957, or dismissal;
- are related up to and including the fourth degree of kinship and affinity to a professor within the Department that is proposing the contractual assignment (<https://www.uniud.it/it/cercapersone?afferenza=107424>) or to the Rector, the Director General or a member of the Board of Governors of the University ([https://www.uniud.it/it/ateneo-uniud/ateneo-uniud-organizzazione/organizational-composizione\\_organ/?organo=Consiglio%20di%20amministrazione%20](https://www.uniud.it/it/ateneo-uniud/ateneo-uniud-organizzazione/organizational-composizione_organ/?organo=Consiglio%20di%20amministrazione%20));
- are already employed on a permanent contract at Italian universities as a full or associate professors or as a researcher on a permanent contract, even if they have ceased their service;
- have already benefited, for at least three years, from contracts pursuant to Article 24 of Italian Law no. 240/2010, as amended by Italian Law no. 79/2022 (RTT);
- have benefited from working relationships referred to in Articles 22, 22-bis and 22-ter and contracts referred to in Article 24 (RTT) of Italian Law 240/2010 for a period of time that, if added to the expected duration of the contract indicated in the call for applications, would exceed a total of 11 years, even if not on a continuous basis.

Candidates are admitted to the selection procedure subject to checks that they possess the necessary requirements; the Administration may at any time, even after the discussion, exclude them from the selection procedure.

Exclusion from the procedure is ordered by a reasoned decree of the Rector and notified to the interested party by registered letter with acknowledgement of receipt or to the certified email address indicated by the candidate during the application phase.

This Administration guarantees equality and equal opportunities between men and women as regards access and conditions at work.

### **Article 3**

#### **Application for admission – methods and deadlines for submission**

The application to participate in the selection procedure, together with the qualifications held, the documents and publications considered useful for the purposes of assessment must be



submitted, **under penalty of exclusion, exclusively** using the appropriate electronic procedure, available at the web address: <https://pica.cineca.it/uniud>. **This is the only valid method to submit applications and the documents considered useful for participating in the selection procedure.**

The application must be prepared and submitted electronically **by and no later than 1 pm (Italian time), on the thirtieth day following that of publication of the call for applications in the Official Gazette of the Italian Republic – IV special series.** If the deadline date is a holiday, the deadline date is extended to the first non-holiday business day.

The application programme can be accessed via SPID, by choosing the University of Udine on the page of available federations; alternatively, the computer application will necessarily require the possession of an email address in order to register with the system. Candidates must enter all the data required for the submission of their application, attaching all documents in electronic PDF format.

The application form must be completed in full, as specified by the online procedure. Up to the deadline date for submitting applications, the procedure allows candidates to save the data entered in “draft” mode so that it can be modified and/or supplemented. The application for admission to the procedure must be completed definitively by the aforesaid deadline and the date of electronic submission will be certified by the computer system by means of a special receipt that will be automatically sent by email. Once the application has been submitted and the confirmation email has been received, candidates will no longer be able to access their application to modify it, but will only be able to withdraw it by using the Withdraw button on the home page (dashboard). If required, a candidate may submit a new application. After the deadline for submitting the application, the system will no longer allow the electronic application form to be accessed or submitted.

If **access is via the Public Digital Identity System (SPID)**, candidates will not be required to sign their application and it will be sufficient to click on the “Submit” button.

**If access is not via SPID**, the application for admission must be submitted and concluded in the manner described in the online procedure:

- **by digitally signing the document on one's own personal computer:** to digitally sign the document one must have the right hardware (for example smart card or USB device with a digital signature certificate issued by an accredited Certifier) or digital signature software with which to generate, from the PDF file of the document downloaded from the site, the signed file in pdf.p7m format to be uploaded to the site itself;

- **by signing the document on the ConFirma server:** to digitally sign the document one must have the right hardware (for example smart card or USB device with a digital signature certificate issued by an accredited Certifier) compatible with the ConFirma service. After signing, it will be possible to download the signed PDF;

- if it is not possible to use one of the above options, a candidate can **sign the document manually:** to manually sign the document, the candidate must download the PDF of the document onto their computer, print it, sign it manually, scan it into a PDF file and upload it to the site.

Each application will be assigned an identification number that, together with the competition code indicated by the IT application, must be specified in all communications regarding the procedure. **The candidate must pay a fee of € 20.00**, as a partial refund of the competition expenses, by selecting the PagoPA method contained in the application. A candidate who resides abroad and does not hold a current account in Italy can select the payment method by bank transfer and make the payment to the bank account in the name of the University of Udine at INTESA SANPAOLO, Via del Monte 1, Udine, IBAN IT59A0306912344100000046097, BIC/SWIFT code BCITITMM indicating the reason for payment: “Selection contribution - Competition code...”. The payment receipt must be attached to the application.

The service may be subject to temporary technical suspensions not dependent on the University. In their applications, candidates must indicate their surname and name, date and place of birth, tax ID code, residence and the address they choose for the purposes of the competition, as well as a telephone number, email address and/or certified email address (recommended choice). The University Administration assumes no responsibility in the event of the recipient being untraceable and of the loss of communications due to inaccurate indication of the candidate's contact details or failure or late communication of any change to the address indicated in the application. Furthermore, the University Administration assumes no responsibility for any failed or late delivery of communications relating to the competition for reasons not attributable to the Administration itself, but to postal or telegraphic problems, that are due to third parties, to unforeseeable circumstances or force majeure.

Candidates must, compulsorily, declare under their own responsibility:

- 1) the citizenship they hold;
- 2) the enjoyment of civil and political rights;
- 3) that they have not been convicted with a final judgment of any criminal offence and that they have no ongoing criminal proceedings. Conversely, they must indicate the convictions and ongoing criminal proceedings;
- 4) if an Italian citizen: the municipality in whose electoral lists they are registered, specifying and indicating, where appropriate, the reasons for not being registered or for having been deleted from the lists; if a foreign citizen: that they enjoy civil and political rights in the state they are part of or their state of origin, or the reasons for not enjoying them;
- 5) their current status with regard to military obligations (only for Italian citizens born up to 1985);
- 6) that they have not been dismissed or dispensed from employment in a Public Administration;
- 7) the address that they have chosen for the purposes of the procedure, if different from their residence, as well as a telephone number, email address and/or certified email address;
- 8) that they are not related up to and including the fourth degree of kinship and affinity to a professor within the Department that proposes the appointment or to the Rector, the Director General or a member of the Board of Governors of the University.
- 9) that they are not already employed on a permanent contract at an Italian university as a full or associate professor or as a researcher, even if they have ceased their service;
- 10) that they have not already benefited, for a period of at least three years, from contracts pursuant to Article 24 of Italian Law no. 240/2010;
- 11) that they have not benefited from working relationships referred to in Articles 22, 22-bis and 22-ter and contracts referred to in Article 24 (RTT) of Italian Law 240/2010 for a period of time that, if added to the expected duration of the contract indicated in the call for applications, would exceed a total of 11 years, even if not on a continuous basis.
- 12) whether or not they have held, for at least one year, a fixed-term researcher contract pursuant to Article 24(3)(a) or held, for at least three years, one or more research grants pursuant to Article 22 of Italian Law no. 240/2010, in the text prior to the entry into force of Italian Law no. 79/2022 that converted Italian Decree Law no. 36/2022;
- 13) whether or not they have attended, for at least thirty-six months, even cumulatively, PhD courses or carried out research activities on the basis of formal awards of assignments, excluding those with no remuneration, at Italian or foreign universities or research institutes, other than the University of Udine;
- 14) that they possess the eligibility requirement specified in Article 2 of this call for applications;
- 15) that they are aware that foreign candidates will be tested as regards their knowledge of the Italian language;
- 16) that they have taken note of the cases of incompatibility provided for by Article 14 of this selection notice;
- 17) any need they may have for assistance and/or additional time in relation to a disability



- pursuant to Italian Law no. 104/1992;
- 18) that they are aware that communications will be issued to candidates, unless otherwise provided for, by means of publication on the institutional website;
  - 19) that they are aware that “anyone who makes false statements, creates forged documents or makes use of them [...] shall be punished pursuant to the Italian Criminal Code and special laws on such matters [...]”, in accordance with the provisions of Article 76 of Italian Presidential Decree no. 445 of 28 December 2000.
  - 20) that they are aware that “[...] if the checks referred to in Article 71 reveal that the content of the declaration is untrue, the declarant will forfeit any benefits resulting from the provision issued on the basis of the untrue declaration”, pursuant to Article 75 of Italian Presidential Decree no. 445 of 28 December 2000.

**Any changes that may occur after candidates have submitted their application for participation must be promptly communicated to the Academic Staff Selection Office.**

Candidates must also attach the following to their application submitted on the IT platform:

- a) a photocopy of a valid identity document (front and back);
- b) curriculum vitae, signed and dated, (drawn up in Italian or in English) which precisely outlines their research, teaching and supplementary teaching and student tutoring activities and, if required, any care assistance activities, together with all the relevant information for the purposes of assessment according to the criteria specified in Italian Ministerial Decree no. 243 of 25 May 2011;
- c) a copy of the fixed-term research contract referred to in Article 24, paragraph 3, letter a) of Law 240/2010 (in the text in force prior to the entry into force of Law No. 79/2022) expiring in 2025 and any extension thereof;
- d) numbered list of scientific publications submitted for the selection process (within the limit referred to in Article 1 of this call for applications). The numbering in the list must correspond to the numbering of the publications uploaded to the IT platform, in compliance with the maximum number if provided for in Article 1. Publications contained in the list but not produced (in the sense that the PDF is missing or only partially uploaded) will not be taken into consideration by the Selection Board;
- e) scientific publications attached for the purposes of the selection process (within the limit referred to in Article 1 of this call for applications), referred to in the previous list;
- f) list of scientific publications held;
- g) additional documents and qualifications that the candidate deems useful to attach for the purposes of the selection process;
- h) in the case of a PhD obtained abroad, the decree of equipollency to the Italian qualification, for those who already possess it, or a copy of the request for academic recognition sent to a University, or a copy of the request for equivalence sent to the Presidency of the Italian Council of Ministers, as provided for by Article 2 of the call for applications;
- i) any medical certification for the enjoyment of the benefits referred to in Italian Law 104/1992 (*need for assistance*);
- j) payment receipt of € 20.00 (if made by bank transfer).

**Only documentation received within the peremptory time limit indicated in the call for applications will be considered validly submitted.** No qualifications awarded or submitted after the expiry date in the call for applications may be entered for assessment. It is not permitted to submit attachments to the application in the form of links to files residing on “online storage/file sharing” services or web pages.

Deeds and documents drawn up abroad by foreign authorities must be legalised by the Italian diplomatic or consular services abroad and, if drawn up in a foreign language, must bear a translation into Italian certified by the competent diplomatic or consular service or by an official translator, as conforming to the foreign text.

**Citizens of the European Union** can prove possession of their qualifications by:

- indicating them in the curriculum vitae, declaring that all the indicated facts and statuses are to be considered declared pursuant to and for the purposes of Articles 46 and 47 of Italian Presidential Decree no. 445 of 28 December 2000;
- attaching the documents in PDF format, declaring their conformity with the original.



**Citizens of non-EU States regularly residing in Italy** may use declarations in lieu referred to in Articles 46 and 47 of Italian Presidential Decree no. 445/2000 only in respect of statuses, personal qualities or facts that may be certified or attested by Italian public bodies, without prejudice to the special provisions contained in the laws and regulations governing immigration and the status of foreigners.

**Citizens of non-EU States authorised to reside in Italy** may use the aforementioned declarations in lieu in cases where they are produced pursuant to international conventions between Italy and the declarant's country of origin.

**For citizens of non-EU States not authorised to reside in Italy**, statuses, personal qualities and facts may be documented by means of certificates or attestations issued by the competent authority of the foreign State, accompanied by an Italian translation authenticated by the Italian consular authority which certifies its conformity to the original.

If the subject matter of the declaration in lieu is not clearly identified in terms of its nature, duration, time setting and the institution concerned, the Selection Committee may disregard it. Pursuant to Article 40 of Italian Presidential Decree no. 445/2000 and subsequent amendments, as amended by Article 15 of Italian Law no. 183/2011, no certifications issued by Public Administrations may be submitted as from 1 January 2012. Therefore, the certificates must be replaced by declarations in lieu of certifications or by affidavits referred to in Articles 46 and 47 of the same Italian Presidential Decree no. 445/2000 as amended. Qualifications submitted with different procedures will not be assessed. The Administration reserves the right to carry out appropriate checks on the veracity of the content of the declarations in lieu. Any candidate who issues false declarations shall be subject to the sanctions provided for by the Italian Criminal Code and related special laws (Article 76 of Italian Presidential Decree no. 445 of 28 December 2000) and shall forfeit any benefits resulting from the provision issued on the basis of the untrue declaration, if the checks carried out by the Administration reveal that the content of the declaration is untrue (Articles 71 and 75 of Italian Presidential Decree no. 445 of 28 December 2000, n. 445).

The Administration will not take into consideration any applications that do not comply with the provisions in this article. **No additional documentation can** be submitted after the deadline.

#### **Article 4 Selection Board**

The Selection Board is appointed by the Rector and is selected in accordance with the provisions contained in Article 8 of the Regulations for fixed-term researchers in Tenure Track, available via the following link:

The day following the date of publication of the Rector's Decree announcing the appointment of the Selection Board, will indicate the start of the period of thirty days for the candidates to submit to the Rector any requests objecting to members of the Selection Board due to incompatibility. Any requests of objection, duly signed and dated, may be sent to the Academic Staff Selection Office, by email to [concorsidoc@uniud.it](mailto:concorsidoc@uniud.it), by certified email to [amce@uniud.it](mailto:amce@uniud.it), by using the form available via the following link: <https://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/info-docenti-ricercatori/modulistica>

If all candidates declare that there are no grounds for objecting to any members of the Selection Board, the deadline shall expire prior to the specified date.

#### **Article 5 Renunciation of candidates from the selection procedure**



If a candidate decides to renounce their participation in the selection procedure after the deadline for submitting applications has expired, they must complete the form available on the University's website at:

### **Article 6 Selection procedures**

The assessment procedure is conducted in two phases:

**Preliminary assessment:** the Selection Board performs the preliminary assessment of the candidates who possess the requirements, expressing a reasoned analytical opinion regarding their qualifications, curriculum and scientific production, including their PhD thesis, according to the criteria and parameters that are also recognized in the international field and outlined in Italian Ministerial Decree no. 243 of 25 May 2011.

The assessment criteria are published on the University's Official Notice Board, as well as on the University website, in the section reserved for selection procedures of fixed-term researchers in Tenure Track, available at the following address: <https://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/ricercatori-a-tempo-determinato-in-tenure-track-rtt>. Following the preliminary assessment, the most deserving candidates on comparison, amounting to between 10 and 20 percent of the original number of candidates and in any case not less than six candidates, will be eligible for the public discussion of their qualifications and scientific production.

If their number is equal to or less than six, all the candidates will be eligible for the discussion. The date and time of the discussion and the list of those eligible will be published no less than twenty days before it takes place, on the University's online Notice Board and on the University's website at: <https://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/ricercatori-a-tempo-determinato-in-tenure-track-rtt>

This notice, to all intents and purposes, serves as official notification, without any further communication being required. Candidates are required to connect to the competition website in order to find out all the necessary information regarding the selection.

**Interview** the second phase consists of the public discussion of qualifications and scientific production. The discussion will be held in Italian and will not involve any scoring, but it will be useful in the overall assessment. At the same time, during the public discussion of the qualifications and scientific production, the Selection Board will ascertain the knowledge of the foreign language, if required, and the adequate knowledge of the Italian language, for foreign candidates, if required. The discussion will take place publicly, via electronic means, using audio and video teleconference tools in compliance with the provisions of the University Guidelines adopted by Rector's Decree no. 344 of 11 April 2022 and available on the University's website at: [https://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/info-docenti-ricercatori/linee\\_guida](https://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/info-docenti-ricercatori/linee_guida)

The candidates must present themselves at the discussion with a valid identity document or equivalent identification document pursuant to Article 35(2) of Italian Presidential Decree no. 445 of 28 December 2000. If a candidate fails to attend the aforementioned scheduled interview, this will be considered an explicit and definitive expression of the candidate's will to withdraw from the selection. The University of Udine declines any responsibility in the event that technical problems, attributable to the interested party, prevent the regular conduct of the public discussion by videoconference.

At the end of the proceedings, the Selection Board, on the basis of the assessment carried out as well as on the basis of the scores awarded, shall draw up the **ranking list on merit** and indicate the successful candidate from the selection procedure.



The maximum attributable score is 100 and is broken down as follows:

- qualifications and curriculum 50 points
- publications 50 points

The final assessment is considered positive if the candidates achieve an overall score of not less than 60/100.

#### **Article 7**

##### **Assessment of qualifications and curriculum**

Pursuant to Article 2 of the aforementioned Ministerial Decree no. 243/2011, when the Selection Board conducts the preliminary comparative assessment of the candidates, it assesses the candidates' curriculum vitae and the following duly documented qualifications:

- a) PhD or equipollent qualification, or, for the sectors concerned, the medical specialisation diploma or equivalent, obtained in Italy or abroad;
- b) any teaching activity at university level in Italy or abroad;
- c) documented training or research activities at qualified Italian or foreign institutes;
- d) documented activities in the clinical field in relation to the sectors in which such specific skills are required;
- e) conduct of project activities in relation to the subject area groups in which they are envisaged;
- f) organisation, direction and coordination of, or participation in, national and international research groups;
- g) ownership of patents in relation to the subject area groups in which they are envisaged;
- h) speaker at national and international congresses and conferences;
- i) national and international awards and recognitions for research;
- j) European specialisation diploma recognised by international Boards, in relation to those subject area groups in which it is envisaged.

Each qualification is assessed, specifically considering the significance that it assumes in terms of the quality and quantity of the research activity carried out by each individual candidate, as well as the coherence of each qualification with the subject area indicated in the call for applications.

#### **Article 8**

##### **Assessment of scientific production**

Pursuant to Article 3 of the aforementioned Italian Ministerial Decree no. 243/2011, when the Selection Board conducts the preliminary comparative assessment of the candidates, it only takes into consideration publications or texts accepted for publication according to the regulations in force, as well as essays included in collective works and articles published in paper-based or digital journals with the exclusion of internal notes or interdepartmental reports if they do not have an international ISSN or ISBN code. The texts and articles accepted for publication by the deadline for the call for applications must be submitted together with the related acceptance letter from the publisher.

No publication can be larger than 30MB. If an individual publication that is to be attached is larger than 30MB, the candidate must contact the office at [concorsidoc@uniud.it](mailto:concorsidoc@uniud.it)

Any publications that are not sent together with the application for participation, according to the procedures and by the deadline indicated in this call for applications, will not be taken into consideration by the Selection Board. It should also be noted that only the documentation relating to qualifications, publications and curricula uploaded by those who submit their application on the PICA platform will be assessed by the Selection Board. In particular, only the information available in the actual application will be used, whereas no use will be made of information available via links to web pages included in the curricula attached to the application.



Each candidate shall produce their publications, with a maximum number of 12 as provided for in Article 1 of this call for applications, declaring that the copy conforms to the original.

If a candidate submits a number of publications exceeding the indicated limit, the Selection Board will proceed to assess a number of publications in line with the above limit and in the order shown in the "List of publications submitted" by the candidate. If the candidate does not submit such a list, the number assessed will be in line with the above limit, taking into account the most recent ones according to date of publication.

It should be noted that, pursuant to Italian Ministerial Decree 243/2011, the PhD thesis, or thesis of an equipollent qualification, is to be considered a publication and, thus, if submitted, it will be counted as being part of the maximum number of permitted publications.

For publications published in Italy up to 01 September 2006, the obligations provided for by Article 1 of Italian Legislative Decree no. 660 of 31 August 1945 and after that date, by Italian Law no. 106 of 15 April 2004, and by Italian Presidential Decree no. 252 of 03 May 2006 must be fulfilled. For publications printed abroad, the following details must appear, if possible: the date, place of publication or, alternatively, the ISBN or ISSN code or other equivalent code.

A translation into Italian or English, certified as compliant with the foreign text, must be attached to the submitted scientific publications written in a foreign language. This translation must be written by a competent diplomatic or consular representation or by an official translator.

The above-mentioned translation is not required when the scientific publications are written in English and when the selection procedure concerns a linguistic field and, therefore, the submitted publications are written in the language or languages for which the selection is announced.

Please note that the judging commission will not evaluate publications written in a language other than those permitted and which do not have an official translation.

The Selection Board conducts the comparative assessment of the publications referred to in this article on the basis of the following criteria:

- a) originality, innovation, methodological rigour and relevance of each scientific publication;
- b) coherence of each publication with the subject area group for which the selection procedure was announced and with the profile indicated in Article 1, or with interdisciplinary issues related to them;
- c) scientific importance of the journal in which each publication appears and its readership within the scientific community;
- d) detailed assessment, also by applying criteria recognised by the relevant international scientific community, of the individual contribution of the candidate when participating in collaborative work.

Within the subject area groups in which their use is consolidated at an international level, the Selection Board shall also make use of the following indicators, when assessing the submitted publications:

- a) total number of citations;
- b) average number of citations per publication;
- c) total "impact factor";
- d) average "impact factor" per publication;
- e) combination of the preceding parameters in order to assess the impact of the candidate's scientific output (Hirsch or similar index).

The Selection Board must also assess the overall weight of the scientific output of the candidates, its intensity and continuity over time, excluding any adequately documented periods when work was involuntarily suspended, with particular reference to the performance of parental duties.

The Selection Board, in compliance with the applicable copyright law, shall use the publications submitted by the candidates exclusively for the purposes of this procedure.

## **Article 9**

### **Checks on the regularity of the documents**



The documents of the Selection Board consist of the minutes of the meetings and their annexes, the ranking list on merit and the final summary report of the work carried out. Within thirty days of these documents being handed over, and after checking on the regularity of the procedure, the Rector shall approve them by decree. Conversely, the Rector shall send the documents back to the Selection Board, assigning them, at the same time, a peremptory deadline for putting them right. The decree approving the documents and the ranking list on merit are made public in the University's official online Notice Board and on the University's website. The terms for any appeals or objections shall run from the date of publication of the approval decree on the University's official online Notice Board. This publication, to all intents and purposes, serves as official notification, without any further communication being required.

#### **Article 10 Proposal to call**

The Department Board that requested the publication of the call for applications, as required by Article 10 of the University Regulations, shall, within 45 days of the issuance of the decree approving the documents, formulate its proposal to call the researcher with the vote in favour of the absolute majority of professors and researchers on permanent and fixed term contracts. The Department's proposal to call is approved by resolution of the University's Board of Governors, after obtaining the opinion of the Academic Senate.

The contract must be signed within ninety days of the conclusion of the selection procedure. If it becomes necessary to replace the successful candidate, because they renounce the assignment or their contract is terminated early, the Department may propose to approach any eligible candidates on the ranking list, compatibly with the available financial coverage.

#### **Article 11 Signing of the contract and rules governing the employment relationship**

At the end of the call procedure referred to in the previous article, the candidate is invited to enter into an individual contract aimed at establishing a fixed-term employment relationship on a **full-time** basis, in order to perform research, teaching, supplementary teaching and student tutoring activities.

The aforementioned contract has a total duration of six years and is not renewable.

The researcher shall perform their work as established by the contract and as part of the planning of the competent bodies. The research activity is carried out under the direction of the Head of the Research Project. The performance of the research activity **must be annual** self-certified by the researcher and validated by the Head of the Research Project or, failing that, by the Director of the Department. For cost reporting on research projects, the notional quantification of annual research, study and teaching activities, together with the related preparatory, assessment and organisational tasks, amounts to 1500 hours per year. The performance of frontal teaching activities and other activities related to teaching is recorded respectively by the register of lessons and the register of teaching commitments.

The rights and duties of the researcher are governed by the current legal provisions on the legal status of university teaching staff and by the current Code of Ethics of the University of Udine. The researcher is required to comply with the internal provisions on the protection of intellectual and industrial property and confidentiality, as well as the directives of the Scientific Supervisor concerning the dissemination of knowledge and know-how acquired during the performance of their activity.

There is a probationary period of three months. During the probationary period, either party may withdraw from the relationship at any time without prior notice, with immediate effect from notification to the other party. Once this probationary period has ended and if the employment relationship has not been terminated by one of the two parties, the researcher is considered confirmed in service.



The termination of the employment relationship is determined by the expiry of the term or by the withdrawal of one of the parties, in the event that a cause occurs that does not allow the continuation of the employment relationship.

The researcher may withdraw from the contract, before the expiry of the final term, giving the University at least sixty days' notice. If the researcher fails to comply with the period of notice requirement, the University has the right to withhold from the researcher an amount corresponding to the remuneration in relation to the period of notice not given.

If a cause occurs that does not allow the continuation, even on a provisional basis, of the employment relationship, withdrawal for just cause referred to in Article 2119 of the Italian Civil Code is allowed.

The researcher is subject to the health checks provided for by Italian Legislative Decree 81/2008 as amended.

The researcher is subject to the disciplinary competence of the Board pursuant to Article 10 of Italian Law no. 240 of 30 December 2010;

For any regulatory aspects not covered by the call for applications, the rules of the Italian Civil Code shall apply to the employment relationship due to compatibility, as well as the current regulations on subordinate employment - also regarding tax, welfare and social security conditions - the Statute and the Regulations of the University of Udine.

The contract does not give rise to any rights regarding the access to permanent positions at the University.

#### **Article 12 Remuneration**

The gross annual income is € 47,070, corresponding to 120% of the initial salary due to a full-time confirmed researcher, subject to subsequent adjustments.

#### **Article 13 Formal documents**

During entry into service, the interested party, if an Italian citizen or citizen of another EU-Member State, shall issue a declaration made pursuant to Italian Presidential Decree no. 445 of 28 December 2000, which indicates:

- a) their enjoyment of civil and political rights on the expiry date of the call for applications;
- b) any pending legal charges on the expiry date of the call for applications;
- c) the composition of their family unit;
- d) that they do not hold other employment positions with the State, local authorities, other Public Administrations or private bodies or, if they do, their opting for the new employment position.

If not belonging to a State of the European Union, the researcher must submit within the period established by the Administration, pursuant to Article 3 of Italian Presidential Decree no. 445 of 28 December 2000, under penalty of forfeiture of the right to the assigned post:

- 1) the certificate with equivalent force to the general criminal record certificate issued by the competent Authority of the State of which the foreign candidate is a national.

The certificate thus issued must be legalised by the Italian diplomatic or consular services abroad and, if drawn up in a foreign language, it must bear a translation into Italian certified by the competent diplomatic or consular service or by an official translator as conforming to the foreign text.

If the foreign citizen is residing in Italy pursuant to Article 3 of Italian Presidential Decree no. 445 of 28 December 2000, in addition to the aforementioned certificate they must also declare the absence of any criminal convictions and charges pending in Italy.

#### **Article 14 System of Incompatibilities**

The fixed-term subordinate employment contract entered into with the researcher **cannot be combined with:**



- PhD scholarships or other scholarships in general or research scholarships, awarded by national or foreign institutions, unless these are aimed at international mobility for research purposes;
- research fellowships or research contracts, also at other universities or public research institutions in Italy or abroad;
- the practice of trade and industry;
- the performance of freelance professional activities;
- any other subordinate employment relationship, whether with public or private entities.

For the duration of the contract, employees of public administrations are granted leave of absence, without social security allowances or contributions, or are placed in a position of secondment if such a position is provided for by the regulations to which they belong. The system of extra-institutional assignments and incompatibilities of researchers is governed by the relevant laws and Regulations in force.

#### **Article 15 Processing of personal data**

In accordance with current legislation on personal data, Reg. (EU) 2016/679 and Italian Legislative Decree 196/2003, the Data Controller is the University of Udine with headquarters in via Palladio 8, 33100 Udine (UD), which can also be contacted at the following email address [datipersonali@uniud.it](mailto:datipersonali@uniud.it). Data is collected for the obligations related to the selection procedure and the possible conclusion and management of the subordinate employment contract. In compliance with the obligations of publicity provided for by law, the outcome of the selection and the assessments are public and, therefore, the names are also disseminated through the website of the Data Controller. The information is disclosed, made available or shared, in accordance with the Law, with the competent Public Administrations in relation to the legal-economic position of the data subject. The data subject may at any time request access, rectification, deletion (compatibly with the Data Controller's retention obligations) and restricted processing or, with reference to personal data processed in an automated manner, the right to portability of the data. Data subjects can always lodge a complaint with the Italian Data Protection Authority. For more information, data subjects should consult the extended privacy policy available on the Data Controller's website, in the privacy section, which can be reached via the following link: <https://www.uniud.it/privacy> under the heading "Selection procedures".

#### **Article 16 Procedure Supervisor**
